11:30	<b>Public Choice: The Benefits and Costs of Collective Action</b> Parth J Shah	<ul style="list-style-type: none"> <li>• To introduce the field of Public Choice why government action may be desirable under conditions of supposed market failure such as the high transaction costs of organizing collective actions, the under-provision of public goods, externalities, and asymmetric information.</li> <li>• The idea of "government failure" and why government interventions themselves are prone to exactly the same or other problems (such as condensed benefits, dispersed costs), which can cause outcomes that are worse than the problems those interventions were supposed to solve.</li> </ul>
